## **Chronology:**

- On December 19, 2017, the FCA US LLC ("FCA US") Vehicle Safety and Regulatory Compliance ("VSRC") organization opened an investigation because of a Product Related Issue opened on December 14, 2017.
- Between December 13, 2017 and December 15, 2017, the supplier and FCA US engineering analyzed two failed parts. The supplier then discovered a sensor was misaligned on their insertion machine that assembled the failed parts.
- Between December 21, 2017 and January 2, 2018, Jefferson North Assembly Plant ("JNAP") analyzed the affected population and provided a final VIN list of suspect vehicles that are outside of FCA US' control.
- As of January 8, 2018, FCA US identified approximately 0 CAIRs, 0 VOQs and 2 field reports related to this issue.
- As of January 8, 2018, total warranty is 0 at 0.0c/1000.
- As of January 8, 2018, FCA US is unaware of any accidents or injuries potentially related to this issue.
- On January 9, 2018, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

## **Description of Remedy:**

Description of Remedy Program: FCA US will conduct a Voluntary Safety Recall of affected vehicles to

inspect the fuel line and replace it as needed.
