Chronology:

- On January 25, 2019, FCA US LLC ("FCA US") Engineering notified the FCA US Vehicle Safety and Regulatory Compliance ("VSRC") organization of a non-operational condition relating to some instrument clusters on 2019 MY Dodge Charger, Dodge Challenger, and Chrysler 300 vehicles.
- On February 8, 2019, FCA US Engineering notified FCA US VSRC that the non-operational condition had been observed on test vehicles.
- On March 7, 2019, FCA US declared voluntary safety recall 19V-203.
- On April 12, 2019, FCA US learned that a small number of Ram 1500 clusters where manufactured with similar suspect software that was the subject of voluntary safety recall 19V-203, and were built into a small number of Product Evaluation Run vehicles.
- During May and June of 2019, FCA US VSRC investigated the suspect population and ultimately determined there is a single suspect vehicle in the United States.
- On July 18, 2019, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicle.

Description of Remedy:

Description of Remedy Program: FCA US will conduct a Voluntary Safety Recall to replace the suspect instrument cluster with an instrument cluster with updated software.
